The Urban Area Development Authority, Mardan hereby invites Expression of Interest (EOI) from interested National and International consultants /firms or Joint Ventures for detailed survey, Re-planning of effected plots, design of existing infrastructure like sewerage system, roads, water supply, parks, main entry Gates to town and other allied services on international standards under the Scheme "Re-Planning / Designing of Existing Infrastructure in Sheikh Maltoon Town (Extension) Phase-III Mardan". The services required also includes preparation of PC-1 along with cost estimates, drawings, sections, bidding documents, technical sanctions and other allied works. Applications are invited on Quality Cum Cost Based Selection (QCBS) method.

**Submission of EOI:**

Applicant shall submit following information/particulars duly supported with necessary documents:-

- Organizational details and financial status duly certified by the concerned Chartered Accountants.
- Registration as Consultant firm with Pakistan Engineering Council (PEC), PCATP, KPRA with renewal up to 30-06-2024.
- The consultants / firms must furnish the successful completion certificate of performance about the consultancy services provided on the project of similar nature and of same or more quantum of work.
- The consultants / firms or Joint Ventures must also submit proof of having proven hand on experience of planning & design of the same nature of work.
- Article of association/memorandum of association or partnership deed whichever is applicable.
- NTN along with up to date tax clearance certificate for last 5 years from tax authorities. The firm must be an active tax payer in the list of F.B.R.
- List of Technical/Non-Technical staff along with their qualification and on the pay roll of the consultant firm for last six (6) months (Attested copies of the appointment letters along with pay slips mentioning the name of bank/branch).
- Undertaking on stamp paper duly verified by Oath Commissioner that firm is neither involved in any litigation or abandoned any work in any department nor black listed as a result and a certificate to the effect that all documents, particulars/information furnished are true and correct.
- In case of Joint Venture a legal agreement between the firms/parties would be required.
- Summary of the overall experience indicating separately the detail of similar assignment duly completed and in progress in the last 05 years.
- Information about the projects implemented with cost of each project, amount of consultancy contract, completion certificate, number of full time staff working on the project, number and expertise consultants/resources persons employed and duration of the project.
- All the interested consultant/ firm or Joint Ventures will have to deposit document fee of Rs.3000/- (non-refundable) in shape of call deposit in the name of Director, UADA Mardan and have to submit same in the sealed envelope containing Technical Proposal.
- The tentative cost of consultancy is rupees Seven (07) million.

The bidder(s) shall be responsible for all fees, costs and expenses incurred in preparing and negotiating any expression of interest as well as proposal submitted by them, and the UADA Mardan shall under no circumstances become liable to reimburse any bidder for any such fees, costs or expenses regardless of the conduct or outcome of the bidding process.

Conditional and incomplete bids will not be entertained. All Federal, Provincial & Local Taxes must be considered while preparing the financial proposal.
